The Treasurer's Report as of November 26, 2008 indicating a balance in the checking account of \$6,500.92, [included in this amount is \$4,430.04 for the Track Renovation Project, and \$2,070.88 in the general fund], Combs-Money Market of \$136.10, Lasater-Savings of \$2,829.25, Combs-Scholarship of \$27,852.00, Lasater-Scholarship of \$21,683.97, Weinmann Scholarship CDs of \$25,000.00, Tennis-Basketball Project account of \$1,445.24, Weinmann McCoy Library CD of \$4,500.00, and Weinmann Track CD of \$25,000.00 The Foundation has total assets of \$114,752.48. Discussion followed. Motion to approve the Treasurer's Reports as of August 31, 2008 was made by Kathy and seconded by Vince. Motion approved by voice vote.

Approval to pay bills: Motion to approve the payment of monthly bills of \$210.26 to Hamilton County Jr/Sr High to pay out Library restricted fund, \$27.60 to ?? to pay for buns for BBQ Dinner, \$7,658.49 to Nelson Electric for work on Basketball Tennis Courts, and \$1,403.00 to Springfield Electric was made by Kathy and seconded by Mary Lee. Motion approved by voice vote.

Old Business

- A. Tennis/Basketball Complex Project Update:
 - 1. Construction Committee; the poles are in the ground for the fencing. The drainage tile is ready to go in at any time. Bobbin will contact Irvin Ragan and Michael Lasater and set up a date to get it installed. We still need to put down the Deco top coating at an estimated cost of \$13,568.00 which includes the installation of the tennis stands and nets and the fence installation and basketball goals estimated at \$6,600.00. We are committed at this time to the installation of the fencing.
 - 2. Fund-Raising Committee; discussion followed. The cake raffles have started at the home basketball games. It was decided to set up the BBQ Grill and sell raffles tickets, also. Also, it was suggested that we write out the announcement for the cake raffle giveaway so that we can acknowledge and thank the person decorating and donating the cake. Also, the winning number needs to be

- announced just as the 1st games ends, before all the people leave the gym. A possible fish fry in February or March was discussed.
- 3. Public Relations Committee; Lovella reported that she took pictures of the poles and workers at the Basketball and Tennis Courts. Hamilton County Chamber of Commerce presented to HCSF a plaque for the 2008 Community Service Award for outstanding community service for the Basketball and Tennis Court Project.
- B. Mailing List/Membership Renewals: Bobbin mailed the classes of 1943, 1958. 1959, 1968, 1984, 1985, 1994, 1995, and 1997 for our membership drive. She also has the class of 1973 [10 years old], class of 1961 [7 years old], and class of 1971 [12 years old] that need to be updated.
