# Hamilton County Schools Foundation <br> Minutes of Meeting Held July 31, 2013

The meeting was called to order by Vince Mitchell at 5:30 PM at the Unit \#10 Office.
Motion to approve the minutes of the May 22, 2013 meeting was made by Lovella and seconded by Mary Lee. Motion approved by voice vote.

The Treasurer's Report as of July 31, 2013, indicating a balance in the checking account of $\$ 36,517.52$, [included in this amount is $\$ 452.80$ for the Track Renovation Project, in the restricted fund; \$9,540.00 in memory of Rodney Rubenacker, \$ 17.33 for Don Hall Scholarship, \$16,975.00 for Lewis \& Mary Reed Scholarship, \$ 710.00 for Lasater Scholarship, \$ 0.00 for Combs Scholarship, \$50.00 for Dahlgren computers, and $\$ 8,772.39$ in the general fund], Combs-Money Market of \$ 929.54, Lasater-Savings of \$3,335.30, Combs-Scholarship of \$28,698.00, Lasater-Scholarship of $\$ 27,982.06$, Weinmann CDs of $\$ 24,175.50$, Banterra - Foundation unrestricted of $\$ 353.97$ and Weinmann Scholarship and Library of $\$ 2,205.30$. Foundation has total assets of $\$ 124,197.19$. Discussion followed. The matching funds checks for technology upgrades were presented to the Preschool, Jr/Sr Hi, and Dahlgren schools. Pictures were taken and Ryan will write an article to be submitted to the McLeansboro Times-Leader. The Foundation received Thank-You notes from Lisa Cross for opening an account with Edward Jones, Ann Johnson for the Summer Reading Program at the McCoy Library, and from the Jr/Sr Hi, Preschool and Dahlgren Grade School for the matching funds for technology upgrades, and Rend Lake College Foundation for the scholarship contributions. The Foundation received a check from Unit \#10 as per Charlie Pryer's request for his retirement gift. Pat contacted Mr. Reed about his intent regarding the Lewis \& Mary Reed Scholarship and the possibility of the Foundation purchasing CDs with a portion of the fund. She received an email from Mr. Reed stating to purchase a CD would be fine. It is their intention to contribute $\$ 5,000$ per year for at least the next ten years. The plan will be to make this year's contribution in December with the matching contribution from A.K. Steel coming early the next year. It was decided to transfer $\$ 10,000.00$ from the Reed Scholarship fund to purchase CDs with a term of no more that 2 years. Motion to approve the Treasurer's Report as of July 31, 2013 was made by Mary Lee and seconded by Jeff. Motion approved by voice vote.
